# CADET NURSE CORPS TO TRAIN STUDENTS

Name Is Selected for Reserve at Conference of Advisory Committee With McNutt

### HE CALLS WORK ESSENTIAL

Administrator Says Plan Must Succeed—Division Formed to Direct the Program

WASHINGTON, June 25-The new Student Nurse Reserve will be called the United States Cadet Nurse Corps, under a decision made today by the National Advisory Committee, called into conference by Paul V. McNutt, Federab Security Administrator.

Mr. McNutt, in welcoming the committee, thanked the members for the speed with which they had responded and stated that the new plan for a Government-subsidized training course for nurses was one which must succeed.

"It must be administered wisely. so that the high standards of the nursing profession will be upheld in this time of emergency, when more nurses must be provided to meet the needs of the armed services and the civilian population," he said.

#### Parran Will Direct Work

Dr. Thomas Parran, surgeon general, who will administer the program, announced the creation of a new, major administrative division in the United States Public Health Service to carry out the program,

Serving with Miss Lucille Petry, its director, will be Mrs. Eugenia Spalding, associate director; Miss Pearl McIver, public health nursing consultant; Miss Jean Henderson, in charge of recruiting and public relations, and the Misses Mary O. Jenney, Elsie Purden and H. Taylor.

"There are no Army schools to provide nurses, such as we had in the last war," Representative Frances P. Bolton, Republican, of Ohio, who sponsored the bill which created the corps, reminded the "Civilian committee. hospitals must furnish the nurses for whom there is such a growing need, a need that will continue after the war itself is over."
